A copy should be enclosed of the purchase orders received from any of these institutes during the last three years.

6. The EOI should be accompanied by a non-refundable fee as a Demand Draft of Rs. **1000/- (Rupees One Thousand) only** in favour of Registrar, Majuli University of Culture, payable at Majuli.
